**ORDER:**

In the reference read above orders were issued on prestigious Telangana Fiber Grid Project which is being implemented for providing high speed broad band connectivity by laying Optical Fiber Cable Network (T-Fiber) and the project is executed by the State owned company namely "Telangana Fiber Grid Corporation Ltd.," which is a Special Purpose Vehicle(SPV) created under Companies Act, 2013. Due to its impact and transformative nature the Government has declared T-Fiber as Vital Purpose Project.

2. As in the above lines the State of Telangana set forth the vision for "Digital Telangana" leveraging the Information Technology Infrastructure and capacities of the State for effective and efficient governance, and lay a foundation for a sustainable and inclusive socio-economic development. To realize this vision, Information Technology, Electronics and Communications Department(ITE&C) of Government of Telangana undertook the implementation of the BharathNet Phase- II project under the "State led model" with an aim to build a state-of-art Optical Fiber Cable Infrastructure across the State. The vision of the Government is to provide an affordable and high-speed broadband connectivity and digital services to every House/Government Departments/Institutions.

3. Government in the line of realization of vision of Digital Telangana and after careful examination of the matter the following guidelines are issued for effective implementation of utilizing the Network services provided by T-Fiber.

- a) All the Government Offices/Institutions under the jurisdiction of State Government including Rural Local Bodies/Urban Local Bodies/all Public Sector Units/ of the State Government and by any other Institution set up by a State Act of the Government shall invariably utilize the services of T-Fiber (Internet/Intranet) value added services as primary service provider.
- b) All the Government Departments/Institutions shall contact T-Fiber for their network connectivity and services and place their orders through web portal **tfiber.telangana.gov.in** for details and guidance.
- c) The approved tariffs and others for T-Fiber services are listed in the annexure appended to this Order. This will be modified from time to time.
- d) The utilization charges/payments for T-Fiber network connectivity and its services shall be made directly to Telangana Fiber Grid Corporation Limited.

- e) Every Government Department/Institutions shall designate a dedicated Nodal Officer who will serve as primary point of contact between the Departments/Institutions and Telangana Fiber Grid Corporation Limited.
  - f) The Nodal Officer shall be responsible for all communications and facilitating order placement and fulfilment, payments and billing related matter and handling service-related issues and resolution.
4. The Managing Director I/c, Telangana Fiber Grid Corporation Limited shall take necessary action in this matter.
